

Overview

The third quarter of 2025 began with a potential budget crisis and ended with a government shutdown. The One Big Beautiful Bill Act became law on July 4, with the bill including provisions that the Congressional Budget Office estimates will add \$340 billion to the fiscal deficit annually for the next 10 years. U.S. equity markets continued to rally across the period as White House trade rhetoric generally remained softer and AI-related companies announced robust earnings and guidance. The quarter concluded with the federal government shutting down after Republicans and Democrats were unable to reach the votes needed to pass a funding bill, primarily due to disagreements over extensions to the Affordable Care Act and reversal of Medicaid cuts.

The U.S. dollar halted its descent in the period, with the U.S. Dollar Index beginning the quarter at 96.9 and ending at 97.8. U.S. equities, as measured by the S&P 500 Index, returned 3.65% on the month and 8.12% on the quarter versus a 3.64% month-over-month (MoM) and 7.05% quarter-over-quarter gain for non-U.S. equities, as measured by the MSCI All Country World Index ex U.S. (Figure 1) U.S. fixed income, as measured by the Bloomberg US Aggregate Bond Index, returned 1.09% and 2.03%, respectively, as the U.S. Treasury yield curve bull steepened across the period. (Figure 2) The lower rate movement along the curve was in part a response to the Federal Reserve cutting the federal funds rate at the end of September as well as renewed expectations for future cuts.

The Fed's cut of 25 basis points (bps), bringing the range to 4.00% to 4.25%, was the first move by the agency since a 25-bp cut in December. At his Jackson Hole Economic Symposium speech in August, Fed Chair Jerome H. Powell noted increased risks to the labor market and the need to weigh those risks against above-trend inflation readings. This dovish pivot in rhetoric boosted the market's confidence in a rate cut at the following month's Federal Open Market Committee (FOMC) meeting. At the end of September, the market was predicting one to two more 25-bp cuts in 2025, based on the Bloomberg World Interest Rate Probability function, with the second cut fully priced in for the January FOMC meeting.

U.S. Treasury Curve

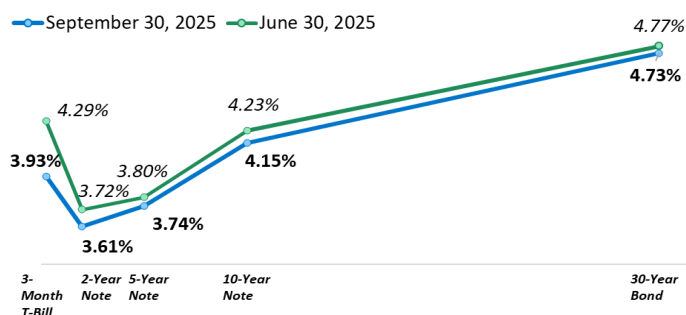

The September nonfarm payrolls report was not released due to the government shutdown. As a result, the market put more focus on alternative data prints like the ADP report, which came in much weaker than expected, showing a MoM decline of 32,000 jobs in September. The ISM Manufacturing PMI increased MoM to 49.1 from 48.7, still in contractionary territory (a number below 50) and near the level where it began the quarter. The ISM Services PMI decreased to 50.0 from 52.0, trailing a consensus estimate of 51.7. August retail sales data (released in September) was stronger than expected at a 0.6% MoM increase versus a 0.2% consensus estimate, marking the third straight month of expansion. August's Consumer Price Index print (also released in September) came in at 2.9% year-over-year, up from 2.7% the prior month.

Eurozone annual inflation came in at 2.2% in September, according to Eurostat's initial flash estimate, up from 2.0% MoM and matching the highest reading since April. The S&P Global Eurozone Manufacturing Purchasing Manufacturers' Index (PMI) decreased MoM to 49.8 from 50.7, moving back into contractionary territory, where the reading had been since mid-2022. The S&P Global Eurozone Services PMI rose to 51.3 from 50.5. The European Central Bank (ECB) held rates at 2.0% over the quarter following a cut in June. At a Sept. 30 meeting in Helsinki, ECB President Christine Lagarde said, "We are well placed to respond if the risks to inflation shift, or if new shocks emerge that threaten (our) target," suggesting the ECB's position is not fixed. Investors have lowered their expectations for further easing.

In China, manufacturing and services data was mixed in September. The China Manufacturing PMI increased MoM to 49.8 from 49.4 while the China Services PMI decreased to 50.0 from 50.3. On the quarter, both readings were also mixed, the manufacturing number ticked lower, and the services number ticked higher. The People's Bank of China (PBOC) held rates steady across the quarter, in line with market expectations. PBOC Governor Pan Gongsheng stated at a Sept. 22 news briefing, "Looking ahead, we will comprehensively use a variety of monetary policy tools based on macroeconomic conditions and changes in the situation." The statement was seen by analysts as the central bank trying to reassure markets that the PBOC will use its tools to try to ensure ample liquidity, drive down funding costs and support the economy.

In Japan, September manufacturing and services data was also mixed. The S&P Global Japan Manufacturing PMI decreased MoM to 48.5 from 49.7 while the S&P Global Japan Services PMI increased to 53.3 from 53.1. Both readings were down on the quarter. August inflation data for Japan (released in September) moved lower MoM to 2.7% from 3.1%, as measured by the Japan CPI Nationwide Ex Fresh Food YoY Index, the third straight month of deceleration. The Bank of Japan maintained its policy rate of 50 bps across the quarter, with its next meeting in October.

Heading into the last quarter of the year, investors face a complex landscape shaped by changing trade policy, geopolitical instability, uneven central bank responses and mixed U.S. consumer spending. In the U.S., the labor market is beginning to stall, putting the Fed's dual mandate of price stability and maximum employment in conflict. Around the globe, administrations continue to struggle with rightsizing their fiscal policy, as budget rationalization clashes with ever-growing demands for government benefits. We remain cautious given worsening fiscal concerns combined with record high valuations, encouraging a more nuanced approach to portfolio construction.

Investment Objective

The Core Fixed Income Fund's objective is to seek to maximize current income and total return.

Investment Philosophy

DoubleLine believes that active asset allocation of the Fund's investments is of paramount importance in their efforts to mitigate risk and achieve better risk-adjusted returns.

Investment Process

The DoubleLine Fixed Income Asset Allocation Committee, led by Jeffrey Gundlach, determines whether to over-or-underweight a sector based on economic outlook, sector fundamentals and relative value.

Fund Attribution

In the third quarter of 2025, the DoubleLine Core Fixed Income Fund performed in line with the benchmark Bloomberg US Aggregate Bond Index return of 2.03%. Financial markets delivered strong, broad-based gains in the period as improving trade sentiment and a shift toward dovish monetary policy lifted investor confidence. The Federal Reserve's September rate cut, its first since 2024, and dovish guidance supported rallies across risk assets while U.S. Treasury yields declined. Every sector of the Fund generated a positive return, with Agency mortgage-backed securities (MBS) and investment grade corporates the biggest contributors to Fund performance, as these long-duration sectors benefited from falling interest rates over the period. Non-U.S. dollar bonds were the laggards, impacted by the dollar strengthening slightly during the period.

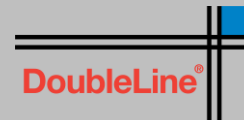

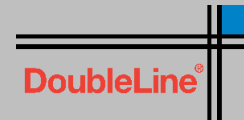

Investment Objective

The Fund's objective is to seek high total return from current income and capital appreciation.

Investment Philosophy and Process

The Emerging Markets investment philosophy at DoubleLine is anchored by four key principles:

1. Emerging Markets debt is a secular improving credit story.
2. Selection across regions, countries, sectors and issuers is fundamental to credit risk management.
3. Avoiding potential problem credits and minimizing credit losses are as critical as selecting stable or improving credits.
4. Total returns will be derived from current income and capital gains.

The Fund's investable universe includes sovereign bonds, corporate bonds, local currency bonds, distressed debt, convertible bonds, and structured finance.

The team's process emphasizes global and industry selection to generate attractive risk-adjusted returns from income and capital appreciation.

Fund Attribution

In the third quarter of 2025, the DoubleLine Emerging Markets Fixed Income Fund underperformed the benchmark J.P. Morgan Emerging Markets Bond Index Global Diversified return of 4.75%. Emerging markets (EM) bonds posted positive returns over the quarter, supported by a rally in U.S. Treasury yields and continued spread compression. Over the period, EM sovereigns outperformed corporates while high yield debt outperformed investment grade debt. The biggest contributor to Fund performance was the Fund's lack of exposure to Argentina. The biggest detractors were the Fund's overweight to corporates relative to the index, as the asset class lagged the performance of sovereigns, and the Fund's overweight to Brazil.

Credit spreads tightened in this long-duration sector due to favorable supply-demand technical factors coupled with a resilient outlook on housing fundamentals. High yield corporates were the laggards, primarily due to the Fund's smaller allocation to corporate credit in favor of securitized credit.

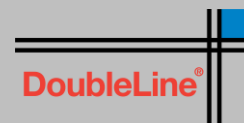

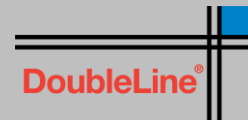

The markets had largely recovered from the "Liberation Day" sell-off by the start of the quarter, and valuations were generally tight throughout the period. The biggest contributors to Fund performance were an allocation to names rated B and being underweight relative to the index to loans rated BB and CCC. As the quarter progressed, the Fund increased exposure to higher-quality names, taking the overall spread of the portfolio down and helping sidestep idiosyncratic credits that moved lower. Conversely in terms of performance, the Fund maintained a higher weighted average dollar price than the index, so the Fund was negatively impacted as discount names rallied and the proportion of loans trading near par increased.

This dovish policy shift led to positive bond returns across most sectors. The biggest contributor by sector to Fund performance was Agency mortgage-backed securities, which experienced spread compression due to declining interest-rate volatility and robust investor demand. The Fund's Treasury exposures also contributed, as these assets rallied in sympathy with risk markets.

The Fund seeks to construct an investment portfolio in emerging markets sovereign, quasi-sovereign and private (non-government) issuers with a dollar-weighted average effective duration of three years or less.

The Fund employs a value-seeking investment approach using bottom-up research process linking credit fundamentals, market valuations and portfolio strategy. The team uses research combined with proprietary scenario analysis using a wide range of possible outcomes, active portfolio management, sector rotation, and a strong sell discipline. 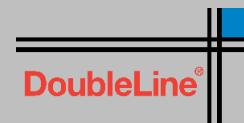

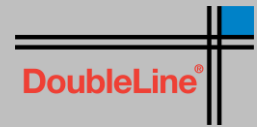

Investment Objective

The Federal Reserve's September rate cut, its first since 2024, and dovish guidance supported rallies across equities and credit while U.S. Treasury yields declined. Every sector of the Fund generated a positive return, with non-Agency residential mortgage-backed securities (RMBS) the biggest contributor to Fund performance.. Commercial MBS were the laggards, largely due to their short duration profiles.

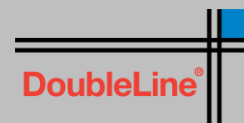

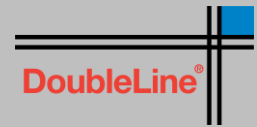

Investment Objective

During the quarter, the Shiller Barclays CAPE® U.S. Sector Total Return USD Index, to which the Fund gained exposure through the use of swap contracts, was allocated to four sectors: consumer staples, communication services, materials and real estate. During the period, three of the four sector allocations appreciated in value. The communication services allocation was the biggest contributor to Fund performance; consumer staples was the detractor. The Fund's fixed-income portfolio increased in value during the period, with each sector appreciating. The biggest contributor to portfolio performance by sector was emerging markets fixed income. The laggard was commercial mortgage-backed securities.

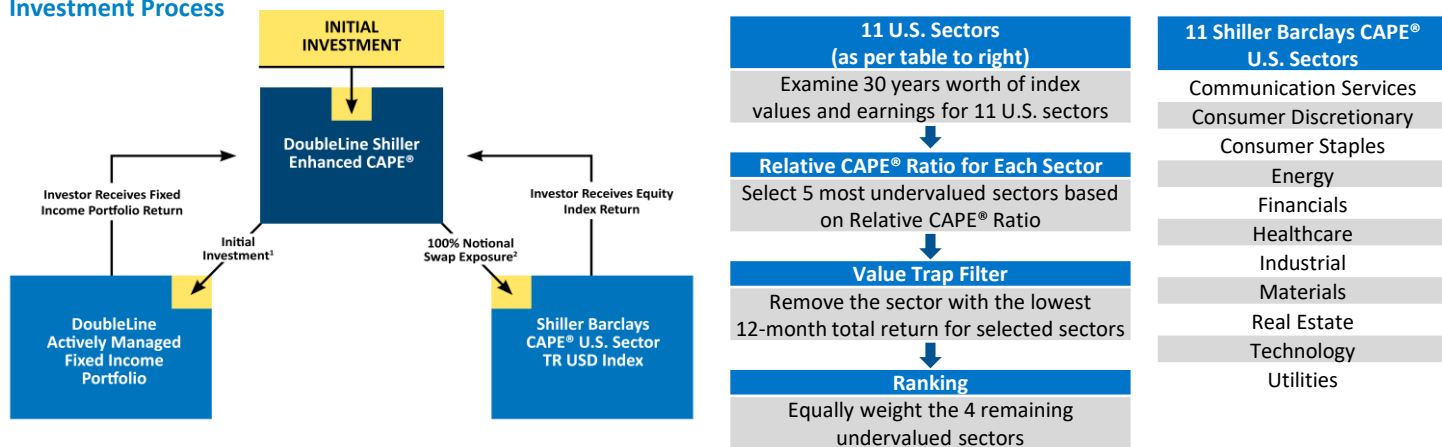

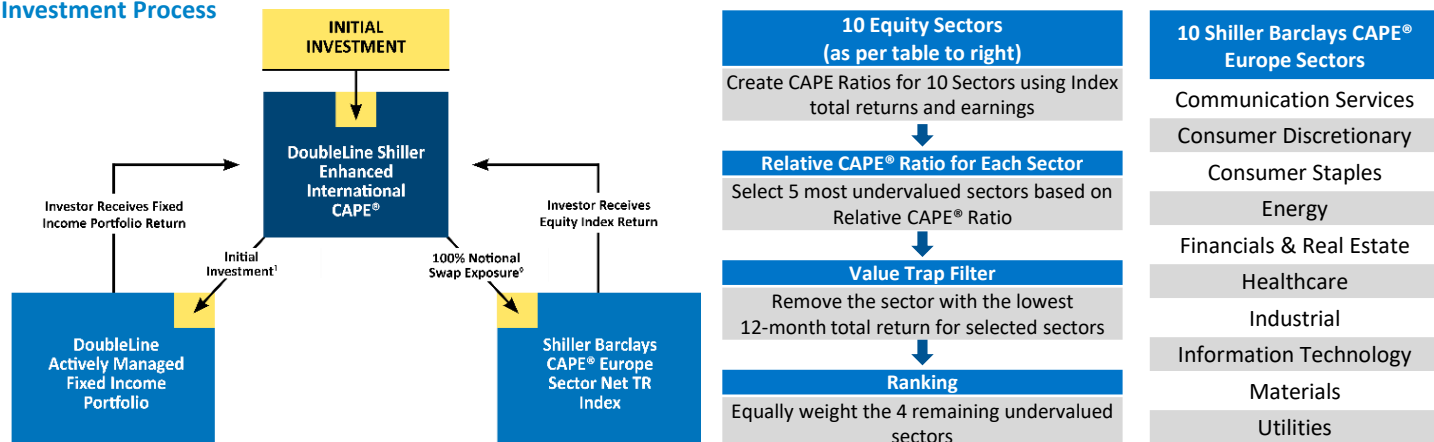

In the third quarter of 2025, the DoubleLine Strategic Commodity Fund underperformed the benchmark Bloomberg Commodity (BCOM) Total Return Index return of 3.65%. During the quarter, the Fund was allocated to the Morgan Stanley Backwardation Focused Multi-Commodity Index ("MSBFMCI" beta exposure) and the DoubleLine Commodity Long Short Strategy ("DCLSS" alpha exposure), which the Fund gained exposure to through the use of swap contracts. The Fund's exposure to the MSBFMCI increased in value but underperformed the BCOM Total Return Index, which contributed to Fund performance. The Fund's exposure to the DCLSS increased in value but underperformed the BCOM Total Return Index, which contributed to Fund performance. The Fund's use of derivative instruments to gain exposure to commodities facilitated investment of the Fund's remaining assets in U.S. Treasuries, which increased in value.

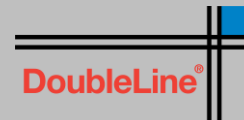

Investment Objective

Investment Philosophy

DoubleLine's portfolio management team believes the most reliable way to enhance returns is through active management of both interest rate and credit exposure combined with bottom-up security selection while maintaining active risk management constraints.

Investment Approach

The Fund invests primarily in structured products fixed income, actively allocating between government-backed Agency MBS and U.S. Treasuries, and structured products credit. Interest rate and credit risks are actively managed with the goal of providing enhanced risk-adjusted returns through various interest rate and economic environments.

Investment Process

The Portfolio Team meets monthly to assess relative value and potential risks and implements a consistent, proven approach that combines top-down sector allocation with bottom-up security selection forms a cornerstone of the investment process.

Fund Attribution

In the third quarter of 2025, the DoubleLine Total Return Bond Fund outperformed the benchmark Bloomberg US Aggregate Bond Index return of 2.03%. Financial markets delivered strong, broad-based gains in the quarter as improving trade sentiment and a shift toward dovish monetary policy lifted investor confidence. The Federal Reserve's September rate cut, its first since 2024, and dovish guidance supported rallies across equities and credit while U.S. Treasury yields declined. Every sector of the Fund generated a positive return, with Agency mortgage-backed securities the biggest contributor to Fund performance. These assets benefited from spread compression and the rally in interest rates over the quarter. Collateralized loan obligations were the laggards, as their floating interest rates and relatively short duration profiles precluded them from duration-related price gains.

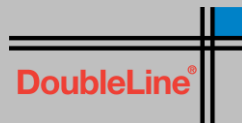

Index Definitions

Bloomberg Long US Government/Credit Index includes publicly issued U.S. Treasury debt, U.S. government agency debt, taxable debt issued by U.S. states and territories and their political subdivisions, debt issued by U.S. and non-U.S. corporations, non-U.S. government debt and supranational debt.

Bloomberg CMBS Investment Grade Aaa 1-3.5 Year Index measures the market of Aaa U.S. Agency and non-Agency conduit and fusion commercial mortgage-backed securities (CMBS) deals with a minimum current deal size of \$300 million. Securities must have a remaining average life of at least one year but less than 3.5 years.

Bloomberg Commodity Index (BCOM) is calculated on an excess return basis and reflects commodity futures price movements. The index rebalances annually weighted 2/3 by trading volume and 1/3 by world production and weight-caps are applied at the commodity, sector and group level for diversification. 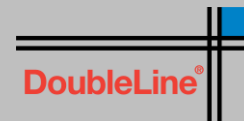

It seeks to calculate the chances of a rate hike at each of the FOMC meetings using futures trading data.

Collateralized Loan Obligation (CLO) – Single security backed by a pool of debt.

Conduit Loans – Type of loans, also known as commercial mortgage-backed securities (CMBS) loans, that are commercial real estate loans pooled together with similar commercial mortgages and sold on the secondary market. On the secondary market, conduit loans are divided into tranches based on risk, return and loan maturity.

Consumer Price Index (CPI) – This index, compiled by the U.S. Bureau of Labor Statistics, examines the weighted average of the prices of a basket of consumer goods and services, such as transportation, food and medical care. It is calculated by averaging price changes for each item in the basket. Changes in the CPI are used to assess price changes associated with the cost of living. The CPI is one of the most frequently used statistics for identifying periods of inflation or deflation.

Distressed Exchange – A bank loan distressed exchange is an out-of-court negotiation where a company facing financial difficulties proposes to exchange existing debt for new debt, often with a reduced principal amount or modified terms, to avoid bankruptcy.

Dow Jones Industrial Average (DJIA) – This index tracks 30 large publicly owned companies trading on the New York Stock Exchange and the Nasdaq. It is price-weighted, unlike stock indices, which use market capitalization. Furthermore, the DJIA does not use a weighted arithmetic mean.

Duration – A commonly used measure of the potential volatility of the price of debt securities in response to a change in interest rates prior to maturity. Securities with longer duration generally have more volatile prices than securities of comparable quality with shorter duration.

Fannie Mae (FNMA) – The Federal National Mortgage Association (Fannie Mae) is a government-sponsored enterprise (GSE) chartered by Congress in 1938 during the Depression to stimulate home ownership and provide liquidity to the mortgage market. Its purpose is to help moderate- to low-income borrowers obtain financing for a home.

Federal Funds Rate – Target interest rate, set by the Federal Reserve at its Federal Open Market Committee (FOMC) meetings, at which commercial banks borrow and lend their excess reserves to each other overnight. The Fed sets a target federal funds rate eight times a year, based on prevailing economic conditions.

Federal Open Market Committee (FOMC) – Branch of the Federal Reserve System that determines the direction of monetary policy specifically by directing open market operations. The FOMC comprises the seven board governors and five (out of 12) Federal Reserve Bank presidents.

Ginnie Mae (GNMA) – The Government National Mortgage Association (Ginnie Mae) is a federal government corporation that guarantees the timely payment of principal and interest on mortgage-backed securities (MBS) issued by approved lenders. Ginnie Mae’s guarantee allows mortgage lenders to obtain a better price for MBS in the capital markets.

Global Industry Classification Standard (GICS) – Hierarchical industry classification system, created by Morgan Stanley Capital International and S&P Dow Jones Indices in 1999, comprising four tiers going from broadest to narrowest to classify companies by industry: sectors, industry groups, industries and subindustries. The 11 GICS sectors are: energy, materials, industrials, consumer discretionary, consumer staples, health care, financials, information technology, real estate, communication services and utilities.

Gross Domestic Product (GDP) – Market value of all final goods and services produced within a country in a given period. GDP is considered an indicator of a country's standard of living.

High Yield (HY) – Bonds that pay higher interest rates because they have lower credit ratings than investment grade (IG) bonds. HY bonds are more likely to default, so they must pay a higher yield than IG bonds to compensate investors.

ICE BofA U.S. Fixed-Rate Miscellaneous Asset-Backed Securities (ABS) Index – A subset of the ICE BofA U.S. Fixed-Rate ABS Index, including all ABS collateralized by anything other than auto loans, home equity loans, manufactured housing, credit card receivables and utility assets. The ICE BofA U.S. Fixed-Rate ABS Index tracks the performance of U.S. dollar-denominated, investment grade (IG), asset-backed securities publicly issued in the U.S. domestic market. Qualifying securities must have an IG rating based on an average of Moody's, S&P and Fitch.

Investment Grade (IG) – Rating that signifies a municipal or corporate bond presents a relatively low risk of default. Bonds below this designation are considered to have a high risk of default and are commonly referred to as high yield (HY) or "junk bonds." The higher the bond rating the more likely the bond will return 100 cents on the U.S. dollar.

ISM Manufacturing PMI – This index (which used to be called the ISM Manufacturing Purchasing Managers Index) is compiled by the Institute for Supply Management and tracks the economic health of the manufacturing sector. The index is based on five major indicators: new orders, inventory levels, production, supplier deliveries and employment environment. A reading above 50 indicates an expansion of the sector, a reading below 50 represents a contraction, and 50 indicates no change.

ISM Services PMI – This index (which used to be called the ISM Non-Manufacturing Purchasing Managers Index) is compiled by the Institute for Supply Management and tracks the economic health of the services (formerly nonmanufacturing) sector. A reading above 50 indicates an expansion of the sector, a reading below 50 represents a contraction, and 50 indicates no change.

J.P. Morgan Collateralized Loan Obligation (CLO) Total Return Index – This index is a total return subindex of the J.P. Morgan Collateralized Loan Obligation Index (CLOIE), which is a market value-weighted index consisting of U.S. dollar-denominated CLOs.

J.P. Morgan Corporate Emerging Markets Bond Index Broad Diversified (CEMBI BD) – This index is a uniquely weighted version of the CEMBI, which is a market capitalization-weighted index consisting of U.S. dollar-denominated emerging markets corporate bonds. It limits the weights of index countries with larger debt stocks by only including specified portions of those countries' eligible current face amounts of debt outstanding.

J.P. Morgan Emerging Markets Bond Index Global Diversified (EMBI GD) – This index is a uniquely weighted version of the EMBI, which tracks emerging markets (EM) bonds and comprises sovereign debt and EM corporate bonds. It limits the weights of index countries with larger debt stocks by only including specified portions of those countries' eligible current face amounts of debt outstanding.

J.P. Morgan Government Bond Index Emerging Markets Global Diversified (GBI-EM GD) – This custom-weighted index tracks local currency bonds issued by emerging markets governments, excluding China and India, and has a broader roster of countries than the base GBI-EM, which limits inclusion to countries that are readily accessible and where no impediments exist for foreign investors.

Japan National CPI ex Fresh Food Index – Japan's National Consumer Price Index (CPI) is released by the Statistics Bureau of Japan on a monthly basis and measures the price fluctuation of goods and services purchased by households nationwide excluding fresh food, whose prices fluctuate depending on the weather.

Last Cash Flow (LCF) – Last revenue stream paid to a bond over a given period.

Legacy RMBS – Name for private-label, aka non-Agency, residential mortgage-backed securities (RMBS) issued before the shift to stricter post-Global Financial Crisis (GFC) guidelines. RMBS issued post-GFC are referred to as "RMBS 2.0."

Liability Management Exercise (LME) – Strategic process used by companies to manage, modify or optimize outstanding debt, often as an alternative to bankruptcy or traditional restructuring. LMEs involve techniques such as debt exchanges, maturity extensions, tender offers and covenant modifications.

Morningstar LSTA US Leveraged Loan Index – This market capitalization-weighted index tracks the U.S. leveraged loan market.

Morningstar LSTA US Leveraged Loan PR USD Index – This index (formerly the S&P/LSTA Leveraged Loan Price Index) tracks the prices of institutional weighted loans based on market weightings, spreads and interest payments.

Morningstar LSTA US Leveraged Loan TR USD Index – This index (formerly the S&P/LSTA Leveraged Loan Index) tracks the market-weighted performance of institutional weighted loans based on market weightings, spreads and interest payments.

MSCI All Country World Index (MSCI ACWI) – This market capitalization-weighted index is designed to provide a broad measure of stock performance throughout the world. It comprises stocks from 23 developed countries and 24 emerging markets.

MSCI Emerging Markets Index (MSCI EMI) – This index captures large- and midcapitalization representation across 24 emerging markets countries. With 1,440 constituents, the index covers approximately 85% of the free-float-adjusted market cap in each country.

Par – Short for "par value," par can refer to bonds, preferred stock, common stock or currencies, with different meanings depending on the context. Par most commonly refers to bonds, in which case, it means the face value, or value at which the bond will be redeemed at maturity.

RCA Commercial Property Price Index (CPPI) – This index describes various nonresidential property types for the U.S. (10 monthly series from 2000). It is a periodic same-property, round-trip investment, price-change index of the U.S. commercial investment property market. The dataset contains 20 monthly indicators.

Russell 1000 Growth (RLG) Index – This index measures the performance of the large-capitalization growth segment of the U.S. equity universe. It includes Russell 1000 Index companies with higher price-to-book ratios and higher forecasted growth values. Growth stocks are shares in a company that are anticipated to grow at a rate significantly above the average growth for the market.

S&P 500 Equal Weight Index (EWI) – This index is the equal-weight version of the widely used S&P 500 Index. The S&P 500 EWI includes the same constituents as the capitalization-weighted parent index, but each company in the S&P 500 EWI is allocated a fixed weight, or 0.2% of the index, at each quarterly rebalance.

S&P 500 Index – This unmanaged capitalization-weighted index of the stocks of the 500 largest publicly traded U.S. companies is designed to measure performance of the broad domestic economy through changes in the aggregate market value of the 500 stocks, which represent all major industries.

S&P Global Eurozone Manufacturing Purchasing Managers' Index (PMI) – This index measures the performance of the manufacturing sector derived from a survey of 3,000 manufacturing firms and includes national data for Germany, France, Italy, Spain, the Netherlands, Austria, the Republic of Ireland and Greece. The PMI is based on five individual indices: new orders (30%), output (25%), employment (20%), suppliers' delivery times (15%) and stock of items purchased (10%), with the delivery times index inverted to move in a comparable direction. A reading above 50 indicates an expansion of the sector, a reading below 50 represents a contraction, and 50 indicates no change.

S&P Global Eurozone Services Purchasing Managers' Index (PMI) – This index is based on original survey data from a representative panel of around 2,000 private service sector firms. National data is included for Germany, France, Italy, Spain and the Republic of Ireland. These countries account for an estimated 78% of eurozone private-sector services output. A reading above 50 indicates an expansion of the sector, a reading below 50 represents a contraction, and 50 indicates no change.

S&P Global Japan Manufacturing PMI – This index is a monthly indicator of manufacturing sector performance, based on survey responses from a panel of approximately 400 manufacturers. Survey participants report changes compared to the previous month across several business variables. A reading above 50 signals expansion while below 50 indicates contraction. The headline figure is a weighted composite of five key components: new orders (30%), output (25%), employment (20%), suppliers' delivery times (15%) and stocks of purchases (10%).

S&P GSCI – This index (formerly the Goldman Sachs Commodity Index) measures investment in the commodity markets and commodity market performance over time.

Spread – Difference between yields on differing debt instruments, calculated by deducting the yield of one instrument from another. The higher the yield spread, the greater the difference between the yields offered by each instrument. The spread can be measured between debt instruments of differing maturities, credit ratings or risk.

Spread to Maturity (STM) – Measure of return from a floating-rate note relative to that from its index or reference rate, such as the Secured Overnight Financing Rate (SOFR), calculated by discounting future cash flows on a bond basis.

Tenor – Length of time remaining before a financial contract expires. It is sometimes used interchangeably with the term maturity, although the terms have distinct meanings. Tenor is used in relation to bank loans, insurance contracts and derivative products.

Treasury Inflation-Protected Securities (TIPS) – Type of Treasury security issued by the U.S. government that is indexed to inflation in order to protect investors from a decline in the purchasing power of their money. As inflation rises, TIPS adjust in price to maintain their real value.

U-3 Unemployment Rate – Officially recognized rate of unemployment, compiled and released monthly by the U.S. Bureau of Labor Statistics, measuring the number of unemployed people as a percentage of the labor force.

U.S. Dollar Index (DXY) – A weighted geometric mean of the U.S. dollar's value relative to a basket of six major foreign currencies: the euro, Japanese yen, British pound, Canadian dollar, Swedish krona and Swiss franc.

Value Stock – Share of a company that appears to trade at a lower price relative to the company's fundamentals, such as dividends, earnings or sales, making it appealing to value investors.

Yield to Maturity (YTM) – The total return anticipated on a bond if the bond is held until it matures. Yield to maturity is considered a long-term bond yield but is expressed as an annual rate.

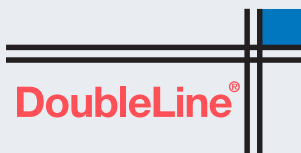
